

Finlay's Used Vehicle Warranty (FUVW)

Terms and Conditions

Valid from 03/2013

Finlay Motor Group (the Company) gives to you, the customer a warranty as follows:

1. The Company warrants that if a failure due to faulty workmanship or materials appears in any part of your vehicle as originally manufactured other than those specifically excluded (see below) it will be repaired (or replaced at the Company's option) free of charge subject to the following conditions and exclusions. Should Finlay Motor Group consider it necessary for an alleged defective part to be returned to the Company for adjudication, you agree to pay the repairer in full for work carried out, and if the Company agrees that FUVW applies then such payment shall be returned.

Warranty Limitations

2. FUVW does not apply to failures caused by accidental damage, misuse or neglect or which are not referred to Finlay Motor Group within seven days; and it will terminate automatically if your vehicle is at any time modified or used for short term rentals, hire or taxi services, racing or rallying; or if the odometer fitted to your vehicle appears to have been tampered with in any way; or if it is not regularly serviced in accordance with the Company's Standard Service Schedule for that vehicle by Finlay Motor Group.

The following components are excluded from warranty:

- **NORMAL WEAR AND TEAR PARTS** - Ancillary drive belts, batteries, brake friction material (including discs), bulbs, clutch facings, Dual Mass Flywheels, exhaust pipes and silencers, DPFs fuses, lamps, shock absorbers and MacPherson struts, tyres, wiper blades, checks and adjustments.
- **TRIM AND BODYWORK** - Interior trims, glass (heating elements are covered), seat covers and pads, bumpers, mouldings, paint, sheet metal, water ingress, weather strips, body seals, aerials and wheels.
- **STANDARD SERVICE PARTS** - Air cleaners, pollen/ odour filters (where applicable), fuel filters, oil filters and gaskets, spark plugs, engine oils & most fluids.

Warranty Conditions

3. FUVW does not in any event apply beyond The Republic of Ireland.

4. Before any work can be carried out under your FUVW contract you must produce your Vehicle Service History Log duly stamped to show scheduled servicing and (if requested) the invoices and/or receipts in respect of those services. All parts replaced will become the property of the Company.

5. FUVW WARRANTY IS IN ADDITION TO & DOES NOT DETRACT FROM YOUR STANDARD NEW VEHICLE WARRANTY (IF APPLICABLE) AND YOUR CONTRACTUAL RIGHTS.

6. Your FUVW Plan entitlement begins on the Used Vehicle Warranty commencement date and will continue until the relevant cover period expires or your vehicle reaches the maximum mileage allowance; or the relevant cover is cancelled in accordance with these Terms and Conditions.

7. The FUVW plan is not transferrable to any other owner. If the vehicle is sold or transferred to any other party during the term of the warranty then the FUVW is considered terminated.

8. Roadside Assistance and Vehicle Hire are excluded from FUVW policies.

Your Obligations:

- 9.** You will be responsible at your expense for:
- a) promptly repairing any damage to your vehicle whether caused by accident, misuse, neglect or otherwise
 - b) any repairs and maintenance due to fitting of parts and accessories to your vehicle at your request or by you, which change the standard specification
 - c) regular checks of your vehicle at the standard frequencies and mileage specified by us in the Manufacturers Service Portfolio in respect of radiator coolant levels, battery, tyres, brake fluid and engine oil levels and adjusting where necessary
 - d) submitting your vehicle for servicing within +/-1,000 miles or one month of a scheduled service as recommended by Finlay Motor Group and set out in your Service Portfolio, making appropriate advance arrangements for an appointment and keeping accurate records of servicing in said Service History Log
 - e) informing the Company immediately of any defect or failure in your vehicle's odometer or of the fitting of any replacement odometer to your vehicle.
